### 6. REQUESTS/PRESENTATIONS

6.1. RGSP PCL RG-6 - Riverside Parking, 212 Riverside Av, File # PL19-0167 Assistant Planner, Sean Morales, presented the staff report.

- Have more cost effective designs been discussed with staff?
- Is the applicant interested in working with staff on an alternate solution?
- Streetscape improvements on Riverside were completed by the City with a cost of approximately \$10 million.
- City's vision for the Riverside Gateway plan area should be carried forward and the guidelines should be met.

The project shall incorporate a knee wall with decorative metal fencing in a design to be approved by the Planning Division. The design shall be similar to the fencing example shown in Figure 2 above. An alternative design that meets the intent of the Riverside Gateway Specific Design Guidelines Section 8.4.5 could be considered and approved by the Planning Division in lieu of the above referenced knee wall and fencing.
