Dear Roseville City Council, City Planning Commission and Others,

My name is Cyndi Hale and I am a member of the Roseville Moose Lodge, and a resident/home owner of Roseville. I grew up in Roseville and attended Roseville schools. I consider Roseville my home town, and am fond of its history. The property surrounding our Lodge (502 Lincoln St.) was recently sold and a proposed development called the Belvedere Town Homes has been submitted to the City of Roseville.

I am opposed to the plans submitted that include demolition of the 103-year-old Hotel Belvedere and believe that the structure has historical significance to our City and should be restored or repurposed. It's a beautiful building with so much history and charm for our beloved town.

I am opposed to the plans submitted that include 18 town homes. Had I been made aware of the apartment homes that were constructed at Main and Washington, resulting in the demolition of Fast Freddie's Pizza and the Roseville Hotel, I would have been opposed and written in then, as well. Those buildings, and the proposed buildings to replace the current Belvedere property, are out of place, don't match the feel and community of the old town/downtown Roseville area, and I personally feel they'd be an eyesore. Especially considering they'd be 4 stories high, when none of the other buildings in downtown/old town are that high.

I am opposed to the plans submitted because I believe residential properties next door to a commercial property may hinder long-standing community fund-raising activities held at the Roseville Moose Lodge. We facilitate many community-based functions throughout the year, benefitting Placer Breast Cancer Foundation and in previous years, we've raised funds and held functions that benefit the Roseville Police Activities League, Stand Up Placer, Homestart, Paradise Camp Fire Victims and other charities.

I am opposed to the plans submitted because the amount of public parking in Historic Old Town is already overloaded and adding new residences will make this problem worse. The argument that the parking lot next to the Moose Lodge now, and the parking between the Belvedere property and the historic Fire House will be sufficient is ridiculous. If it's already difficult for our attendees to find parking during our special events, I can't imagine how many will opt not to attend if they now have to fight for parking with residents of an 18-town home development. I understand that these town homes will have their own garages, yet I'm doubtful that this will be sufficient to accommodate those who may have several driving-age residents in each home.

I am opposed to the plans submitted because the intersection that will be used for access to the proposed project where Lincoln Street connects to Sierra Blvd at the Sierra Vista Bridge (aka "The Crooked Bridge) is already dangerous for vehicles and pedestrians and adding additional traffic from a residential community with 18 homes and likely double the amount of cars in and out, will make this problem worse. When Roseville High School releases their students in the afternoons, and in the morning during drop-offs, it's only worse.

The Roseville Moose Lodge, at its core, is a community center used to raise funds to support various causes. We are a commercial business and hold our largest fund-raisers at night, usually

dinners with live music. Our goal is to find a way to restore or re-purpose the Belvedere and develop the property in a manner that enhances the historic charm of our City without affecting our mission to support children, seniors and other non-profits in our community.
