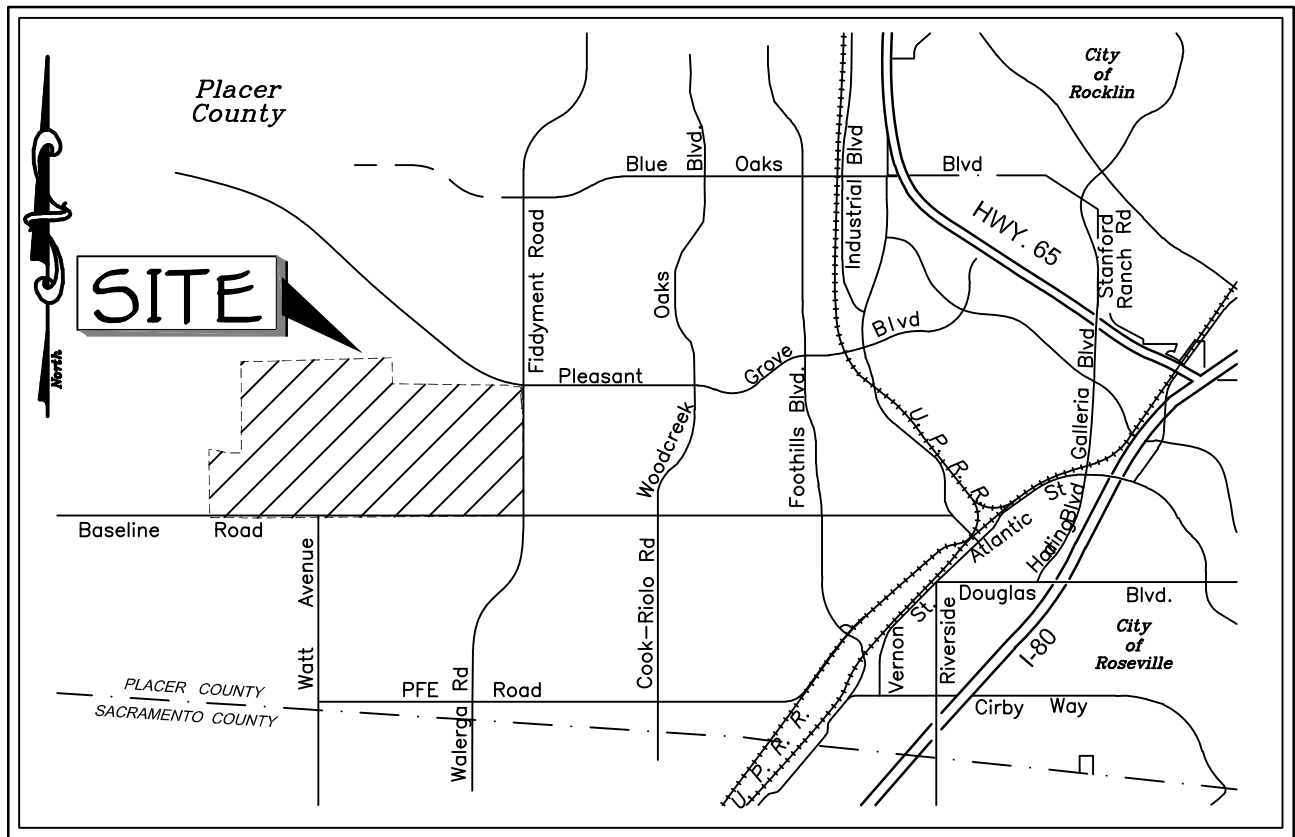




VICINITY MAP
