WHEREAS, CITY and CONTRACTOR previously entered into an Agreement for City of Roseville Transit System Management, Operations and Call Center Services dated September 20, 2017 and amended June 16, 2021 ("Agreement"); and

WHEREAS, CITY desires to amend the Agreement to increase its maximum monetary obligation, consistent with the additional costs resulting from the two (2) year extension provided in Amendment No. 1 to the Agreement; and

WHEREAS, CONTRACTOR is willing and able to provide such services.

NOW, THEREFORE, the parties agree as follows:

1. Section 10 of the Agreement is amended by adding an additional paragraph to read as follows:

"CITY shall pay an additional nine million, five hundred seventeen thousand, five hundred eighteen dollars and thirty-one cents (\$9,517,518.31), in consideration of the

additional services to be provided by CONTRACTOR during the extended term of the Agreement from July 1, 2021 to June 30, 2023, as provided in Amendment No. 1 to the Agreement. This brings CITY's total maximum obligation to twenty-six million, three hundred eighty-eight thousand, eight hundred six dollars and nine cents (\$26,388,806.09)."

2. All other provisions of the Agreement shall remain unchanged and in full force and effect.
