Project Title: Pleasant Grove Wastewater Treatment Plant Ultraviolet Disinfection System Addition Construction

Project Location(s): 5051 Westpark Drive, Roseville, CA 95747. Assessor's Parcel Number 017-101-025-000.

Project Description: The Environmental Utilities Department (EU) recommends City Council adopt a resolution authorizing the City Manager to execute a design-assist agreement, for the Construction Contractor, with Auburn Constructors to provide channel modifications to accommodate a fourth bank in each channel, installation of new UV equipment including a complete installation in channel 4, installation of all new programmable logic controllers and new transformers for electrical infrastructure, testing, and commissioning for the Pleasant Grove Wastewater Treatment Plant (PGWWTP) Ultraviolet Disinfection Addition Project. When originally constructed, only three channels were needed and the fourth channel was built for system expansion to plant designed flow rates and was to be equipped when the treatment flow approached the capacity of the first three channels. Growth in the Pleasant Grove WWTP service area is now generating sufficient flow to justify equipping the fourth channel. The project would accommodate planned growth that has already been considered and evaluated in the Roseville General Plan and General Plan EIR (SCH#2019080418). The project would not result in any additional new capacity or unplanned expansion beyond that which has already been approved.

Public Agency Approving Project: Roseville City Council

Agency/Individual Carrying Out Project: City of Roseville Environmental Utilities Department

Reason why this Project is Exempt: The project qualifies for a Class 1 Categorical Exemption as described in Section 15301 of the California Environmental Quality Act (CEQA) guidelines which states:

"Class 1 (Existing Facilities) consists of the... minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use. Examples include but are not limited to: (b) Existing facilities of both investor and publicly owned utilities used to provide electric power, natural gas, sewerage, or other public utility services."

The project consists of ultraviolet channel modifications, demolition of some old equipment, installation of new equipment, testing, and commissioning of ultraviolet disinfection equipment, automation equipment (programmable logic controllers, instrumentation and electrical infrastructure) for the fourth and last remaining treatment channel located at the PGWWTP. The project would not result in increased capacity or unplanned expansion of use. Consequently, the Class 1 Categorical Exemption applies.
