Project Title: Factory Start Up and Installation Oversight of Ultraviolet Disinfection Equipment at the Pleasant Grove Wastewater Treatment Plant – Sole Source Contract Purchase Agreement

Project Location(s): 5051 Westpark Drive, Roseville, CA 95747. Assessor's Parcel Number 017-101-025-000.

Project Description: The Environmental Utilities Department (EU) recommends City Council adopt a resolution authorizing the City Manager to execute a sole source contract purchase agreement with Trojan Technologies Group ULC for the factory start up and installation oversight of the Ultraviolet Disinfection Equipment at the Pleasant Grove Wastewater Treatment Plant (PGWWTP). The PGWWTP currently uses the Trojan system UV3000Plus for the final disinfection stage of the wastewater treatment process in three of the four currently constructed treatment channels to convey treated water for disinfection. The project would add the Trojan system UV3000Plus to the fourth channel. When originally constructed, only three channels were needed and the fourth channel was built for system expansion to plant designed flow rates and was to be equipped when the treatment flow approached the capacity of the first three channels. Growth in the Pleasant Grove WWTP service area is now generating sufficient flow to justify equipping the fourth channel. Trojan Technologies is the sole manufacturer and distributor of the UV3000Plus. The project would accommodate planned growth that has already been considered and evaluated in the Roseville General Plan and General Plan EIR (SCH#2019080418). The project would not result in any additional new capacity or unplanned expansion beyond that which has already been approved.


Reason why this Project is Exempt: The project qualifies for a Class 1 Categorical Exemption as described in Section 15301 of the California Environmental Quality Act (CEQA) guidelines which states:

"Class 1 (Existing Facilities) consists of the... minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use. Examples include but are not limited to: (b) Existing facilities of both investor and publicly owned utilities used to provide electric power, natural gas, sewerage, or other public utility services."

The project consists of authorizing the purchase of and installation of the Trojan system UV3000Plus for the final disinfection stage of the wastewater treatment process in the fourth and last remaining treatment channel located at the PGWWTP. The project would not result in increased capacity or unplanned expansion of use. Consequently, the Class 1 Categorical Exemption applies.
