## Justification for Budget Adjustment:

Staff recommends a budget adjustment to align the Community Development Block Grant Fund (CDBG) budget with the CDBG Action Plan approved by the City Council in May 2023. This budget adjustment adjusts expenditures in the CDBG Fund by \$248,298 for public services, public facilities improvement projects (Johnson Pool), OOR projects, affordable housing acquisition, and administrative expenses to adhere to the approved Action Plan. In addition to this expenditure adjustment, \$115,155 in CDBG Funds will be carried forward as part of the City's annual encumbrance carryforward process. These two adjustments will increase the existing CDBG Fund budget of \$957,678 to \$1,321,131. This budget adjustment will also increase CDBG Fund revenue by \$195,976, which, in addition to the \$115,155 in grant revenue carried forward for remaining encumbrance balances, will result in an overall increase to the CDBG revenue budget from \$1,010,000 to \$1,321,131. The decrease in the CDBG fund balance accounts for the revenue budget being greater than expenditures at budget adoption.
