    - Review prior One Roseville Council direction
    - Review Council feedback from the interviews
    - Consider additional norms or guidelines
    - Governing in the interest of all residents and not just the residents of a single district - allows for the continuation of accessible customer service, the most effective use of taxpayer resources, and consistency in city services
    - Any member of the City Council may respond to and assist

anyone in the community who calls or contacts them regardless of residence in or representation of any particular district

- Current practices regarding invitations to members of the City Council to events and activities, and the process with respect to appointments to committees and various bodies with remain in effect
- Use neighborhoods to the extent possible
- City Budget Development consistent with the General Principles of Governance adopted by the City Council in the Elections Ordinance, the City shall maintain a citywide focus during the budget development process and in the adopted budget. Revenues and expenditures shall be budgeted on a citywide basis and not tracked by Council district

Redistricting:

- Everything will change with new Council district map
- Council should be neutral and serve whole community
- Elected by district but two still at-large
- Don't put district on business cards majority
- Consistency with city website and business cards communications find a new balance
- Share responsibility of education district verses citywide
- Communicate neighborhoods verses districts
- Elected serves neighborhoods
- Website statement that City Council serves the whole community
- Consensus to use "neighborhood" verses "districts"
- Web page concern, call Mayor, Vice Mayor or any member of Council

City Council were provided a presentation on the Roseville Resident Survey results with Roseville scoring high in many factors.

Ceremonial Events:

- Notifications of celebrations within districts ribbon cutting, ground breaking how do we do it? Making sure Councilmembers within district be notified of events and don't use social media outside of your geographic area courtesies - involve all Council members
- Ceremonial Mayor and/or staff extends invitations to all Councilmembers differs to Mayor's direction - to the extent that the host is acceptable - invite whole Council
- Personal Relationship Invitations people want to talk to the person they elected

#### SURVEY RESULTS

Continuing Response to the Pandemic:

- Return to normal operations in a safe manner as soon as possible (for physical and mental health)

• Restart the City of Roseville news bureau, provide more context about budget and financial conditions including unfunded mandates, enhance outreach to youth/young adults, raise awareness of advocacy efforts

#### Goal C: maintain a safe and healthy community

• Deploy police body cameras; continue focus on homelessness response/and partnerships, ensure service levels align with city growth; strengthen inclusiveness, equality, and justice efforts in partnership with the community for all

#### Goal D: Economic vitality:

• Expand on sports tourism and recreation opportunities, consider options for vacant storefront, job growth incubators and other economic growth

#### Goal E: Deliver exceptional city services

• Return to normal operations while maintaining best practices that we learned from the remote experience such as customer-service improvements and operating efficiencies; address staffing turnover and challenges and succession planning; implement Customer Service Software (formerly known as CRM); maintain vigilance on community standards to address blight and graffiti, hold community cleanups, call in problem areas while serving community

#### Goal F: Invest in well-planned infrastructure and growth

 Revitalize core neighborhoods; support opportunities for more affordable housing; develop strategy and implementation plans for water resiliency and electrification of the transportation grid
