- Law and Regulation Committee, Government Relations Team

Partnerships power advocacy strategy

- Community (SACOG, Chambers, RCONA Cities)
- Issue-specific (NCPA, CMUA, RWA, MISAC, Cal Chiefs)

Engagement activates strategy

- Monthly meetings with legislative representatives
- Advocacy at state and national capitols
- Lobbyists, testimony, regulators, advocacy letters, tours

- Is an element of Council-approved annual legislative advocacy schedule
- Law and Regulation Committee an invaluable resource to the advocacy effort

Proposed Modifications/Critical Concerns

Citywide Legislative Principles

- Advocacy on sales tax, state bond legislation or state ballot measures

Administrative Services

- Support legislation and measures that provide and promote consistency and the promotion of harmonious labor relations

Parks, Recreation, & Libraries Platform/Item

- Support legislation to reinstate state funding for the Building Forward Facilities Improvement Program
- Support legislation that funds increased access and American Disabilities Act improvements to parks and facilities

Public Safety

- Support legislations that invests in first responder health and wellness programs, with a focus on advancing cancer prevention, research, and early detection initiatives

Housing and Community Investment Platform

- Support legislation and appropriations that fully fund assistance for affordable housing, prevention

- National Flood Insurance Program updates and Community Rating System program changes

Environmental Utilities Platform (Modifications)

- Updated section titles to more accurately reflect the City's desired outcomes
- Rearranged goals to more appropriate sections

Environmental Utilities Platform (New Language)

- Advancing Stormwater Management and Green Infrastructure #7 "Actively track, comment and advocate requirements from the state Water Board and Regional Water Boards."
- Advancing Biosolids, Recycled Water and Energy for a Sustainable Future #4 "...allow developers of biogas and electricity to benefit from federal and state funding like e-RINS (Electric Renewables Identification Numbers) so we can use our microturbines to power e-trucks and receive the e-RINS credits."

Critical Concerns

- Implementing the Making Conservation a California Way of Life regulation
- Appropriate Regulatory Offramps
- Municipal Water Systems Performance in Wildfires - Proposed language hand out

- State Agency Collaboration - Foster continued engagement, pursue new opportunities
- UEC Outreach - Showcase unique value of UEC, seek regulatory benefit
- Regional Energy Market - Participate in 2025 regional energy market legislation

Critical Concerns for Upcoming Legislative/Congressional Session(Modifications):

- Grid Reliability Related Programs - Deleted to reflect completed task, acceptance in DEBA
- Supply Chain Disruptions - Modified to reflect updated supply chain efforts
