## 7. MATTERS TO BE HEARD

### 7.1. Citation No. 14733

Appellant: Shannon and Tyler Pierce

- Roseville Municipal Code Section 7.12.010, Animal at Large, second offense
- Roseville Municipal Code Section 7.12.050, Aggressive Behavior

The Complainant, Chad Worrell was not present. The item was trailed to allow Chad Worrell his 15 minutes from the commencement of the hearing to appear per the Administrative Hearing Procedures.

Animal Control Officer Sarah DeRego was present but did not offer testimony.
