1. CALL TO ORDER

7. MATTERS TO BE HEARD

7.1. Citation No. 17769

Appellant: Seyedmohammad Caranizadeh

- Roseville Municipal Code Section 4.25.080(A), Short-Term Rentals, Performance Standards – No permittee shall, for compensation, provide lodging for more than six people at any time in a short-term rental.
- Roseville Municipal Code Section 4.25.080(C), Short-Term Rentals, Performance Standards – All eligible short-term rentals shall be located on a parcel develop with the permittee's primary residence and shall not be rented for more than 182 days per year as a short-term rental.
- Roseville Municipal Code Section 4.25.130(B)(3) Short Term Rentals, Violations – Excessive noise, as defined by Section 9.24.150 of this code, which is disturbing to people of normal sensitivity on adjacent or nearby property or areas open to the public.

 Abatement Property Which Creates a Dangerous Condition Algae
- Roseville Municipal Code Section 14.09.060(A), Water Conservation Water Waste
- Roseville Municipal Code Section 14.09.060(C), Water Conservation
 Water Leak
