### Justification for Budget Adjustment:

The West Side Tank and Pump Station project (400014), with a remaining budget of \$22,028,384 in the Water Construction Fund, requires an additional \$4,284,886 to fully-fund the expenses for a new construction agreement (\$23,481,300), a 10% contingency (\$2,348,130), and related secondary labor for EU Technical Services and SCADA staff (\$483,840).
