## Justification for Budget Adjustment:

The Parks, Recreation & Libraries department is requesting a budget adjustment of \$32,568 to increase the budget for the Turf Conversion and Irrigation Upgrades project (500256) in the Stoneridge CFD 1 using bond refund savings. The spending plan for the bond refunding monies includes two phases of turf conversion. This budget request is needed to complete the first phase of turf conversion. The second phase is expected to begin in FY2028-29. Funding is available in the Roseville Finance Authority Capital Projects fund 3541. There is no impact on the General Fund.
