3. Renewal of Cloud Services:

Notwithstanding any statement to the contrary in the Services Specifications, as defined in the CSA, the parties expressly agree that the Cloud Services acquired under this Order will not Auto-Renew.

4. Price Hold for Cloud Services:

During the services period, You may order additional quantities of the cloud services acquired under this ordering document at the Unit Net Price specified in the Cloud Ordering table above. This price hold does not apply to any renewals or extensions of the cloud services ordered under this ordering document, or to any cloud services other than those listed in the initial purchase under this ordering document.

5. Offer Validity:

This order is valid through May 21, 2017 and shall become binding upon execution by You and acceptance by Oracle of CherryRoad's ordering document.

6. Data Center Region:

End user's services environment (as defined in the end user cloud services agreement) will reside in the United States.

7. Fees:

2. Price Hold for Cloud Services

For those Cloud Services set forth in this order that are not identified as Auto Renewal eligible in the Service Specifications, the Unit Net Price for renewal years two (2) through five (5) year, will not increase during such period. For renewal years six (6) through eight (8), the Unit Net Price for the renewal will not increase by more than four (4) % per year of the Unit Net Price for such Cloud Service set forth in this order. For renewal years nine (9) and ten (10), the Unit Net Price for the renewal will not increase by more than five (5) % per year of the Unit Net Price for such Cloud Service set forth in this order.
